Meet start: 9:00 am Saturday, April 3, 2010
- Location:** Brighton High School Pool, 565 S. 8<sup>th</sup> Ave, Brighton, CO (southwest corner of 8<sup>th</sup> and Southern, enter parking lot from Southern St.).
- Facility:** Indoor, 25-yard, 6-lane pool. Warm down available in diving well.  
The competitions course has not been certified in accordance with 104.2.2C (4)
- Timing:** Electronic timing with touch-pads, back-up buttons, and manual timers on each lane.
- Eligibility:** Open to all swimmers, 12 years of age and under, holding a 2010 USA Swimming membership card. Any swimmer that appears on the CSI exceptions report without registration must come to the meet prepared to show their card. NO deck registrations will be accepted.
- Entry Limits:**
- Each swimmer may enter 5 individual events (Brighton Bullfrogs Swim Team Inc reserves the right to limit entries to stay in the four-hour rule).
  - The meet will be limited to 250 swimmers.

**Entry Procedure:** To participate in this meet, teams shall provide the following to the Entry Coordinator (see contact information below) prior to the entry deadline:

- The completed Colorado Swimming, Inc., Meet Verification Form with an original signature.

**AND**

- A check for the entry fees for the team.

**AND**

- Computer disk containing entries for individual swimmers shall be prepared using Hy-Tek software. Participating teams are responsible for the accuracy of the entries.

**Rules:**

- Current USA Swimming rules will govern at the meet.
- The meet referee will be the final authority for all conduct of the meet.
- All events will be timed finals.
- The meet will be pre-seeded
- The age of the swimmer on the day of the meet will determine the swimmer's age group.
- Unsportsmanlike conduct and lack of respect for property are grounds for dismissal of swimmers and/or spectators for the remainder of the meet.
- Swimmers will be held responsible for damages that they have caused.

- There will be NO SMOKING in the pool area.
- Glass containers are not allowed in the pool area.

**Concessions:** The concession stand will be open during the meet and will be offering a variety of snacks and drinks.

**Scoring:** 16-13-12-11-10-9-7-5-4-3-2-1

**AWARDS:** High Point Trophies for 1<sup>st</sup> through 6<sup>th</sup> for ages 6 and under, 7, 8, 9, 10, 11, 12.

In case of ties for high point trophies, the following tiebreakers shall apply:

- Swimmer that swam the most yards. If it is the same then:
- Swimmer with the smallest cumulative time for all events.
